1. CHARTER FEE

Includes: Accommodation for maximum 8 guests in 4 cabins, fuel for 4 h of the engine work daily, generator work 24/7, fuel for tender transfers to/from the yacht, use of recreational equipment (SUP, kayak, snorkeling gear), crew of 4 and their expenses, insurance of the yacht, re-positioning of the yacht to Dubrovnik for embarkation/disembarkation when possible, Wi – Fi, VAT of 13%

2. FOOD OPTIONS

A) Half board: 350 € pax/week (breakfast + lunch or dinner)

B) Full board: 560 € pax/week (breakfast + lunch + dinner)

Discounts on food options for children: from 0-2 years of age free of charge, from 2-10 years of age -50% discount from 10 - 12 years of age - 30% discount

Extra meal charge: 45 € pax / meal.

3. BEVERAGE OPTIONS

A) Beverages on yacht bar only – by bar price list, in this option clients are not allowed to bring their own beverages on board.

B) All inclusive domestic package - includes Croatian quality wines, beers, spirits, soft drinks, natural and mineral water, coffee, tea, juices – 210 € pax / week.

C) All inclusive dom. non alcoholic package – 105 € pax/week.

D) Beverages completely supplied by clients - cost service of beverages: 700 €/week

4. EXTRA COSTS – can be prepaid as APA (Advance provisioning allowance)

- Port, marina fees and anchorages, entrances for National Parks and Parks of Nature.

- WATER SPORTS: Personal watercraft 150 €/h, Sea scooter 100 €/h,

- Fuel consumption for watersports that require dinghy (waterski and donut ride)

- Delivery Fee for embarkation / disembarkation in any other port except base port, if „empty leg“ caused. There is no extra charge for one way from Split to Dubrovnik or vice versa.

- Any other costs not specifically mentioned as included

NOTE: APA (Advance provisioning allowance) to be paid as a wire transfer to shipping agent's account. Shipping agent fee of 2% will be deducted from the APA.

Booking terms:

Option is placed on explicit e-mail request, and is active until agreed date. Booking needs to be confirmed while option is active. Option expires after agreed date without special warning. Please take care of your option expiration. Booking is confirmed when agreement is signed by both parties and deposit paid.

Payment conditions:

Deposit: 50 % of charter fee – immediately, as confirmation of booking

Balance: 50 % of charter fee + Other costs - not later than 6 weeks before charter commencement

Mean of payment: wire transfer to account of Booking Agent.

* To drive a Personal Watercraft in Croatia one needs to have a boat driving permit with him/her when on the Personal Watercraft. It is forbidden to allow a person to drive a Personal Watercraft if one doesn't have a license with him/her. If the person doesn't have this, it is possible to obtain one while in Croatia.
